Hydroquinone

Synonym: p-Benzenediol; 1,4-Benzenediol

SECTION 3 — HAZARDS IDENTIFICATION

White crystals. Odorless.

Highly toxic by ingestion and inhalation. Corrosive to skin eyes and respiratory tract.

Avoid all body tissue contact. Combustible solid.

SECTION 4 — FIRST AID MEASURES

Call a physician and seek medical attention for further treatment, observation, and support after first aid.

Inhalation: Remove to fresh air at once. If breathing has stopped, give artificial respiration immediately.

Eye or External: Immediately flush with fresh water for at least 15 minutes.

Internal: Do NOT induce vomiting. Rinse mouth. Give large quantities of water for dilution. If vomiting occurs, ensure vomit is not aspirated. Call a physician or poison control at once.

SECTION 5 — FIRE FIGHTING MEASURES

Combustible solid.

Flash point: 165 °C (CC), Autoignition Temperature: 516 °C

Decomposition releases acrid smoke and irritating fumes.

Fire Fighting Instructions: Use a triclass, dry chemical fire extinguisher. Firefighters should wear PPE and SCBA with full facepiece operated in positive pressure mode.

SECTION 6 — ACCIDENTAL RELEASE MEASURES

Restrict unprotected personnel from the area. Sweep up the spill, place in a sealed bag or container, and dispose. Ventilate area and wash spill site after material pickup is complete. See Sections 8 and 13 for further information.

SECTION 7 — HANDLING AND STORAGE

Flinn Suggested Chemical Storage Pattern: Organic #8. Store with phenols and cresols.

Material is air and light sensitive. Keep container tightly closed. Store in a cool, dark, and dry place. Use and dispense in a hood.

SECTION 8 — EXPOSURE CONTROLS, PERSONAL PROTECTION

Avoid contact with eyes, skin, and clothing. Wear chemical splash goggles, chemical-resistant gloves, and a chemical-resistant apron. Use ventilation to keep airborne concentrations below exposure limits. Always wear a NIOSH-approved respirator with proper cartridges or a positive pressure, air-supplied respirator when handling this material in emergency situations (spill or fire).
